S. R. O. No. 342/2017.—In exercise of the powers conferred by the proviso to sub-section (1) of section 5 of the Kerala Local Authorities Entertainments Tax Act, 1961 (20 of 1961), the Government of Kerala hereby make the following amendment to the notification issued under G. O. (P) No. 14/2016/LSGD dated 4th March, 2016 and published as S. R. O. No. 244/2016 in the Kerala Gazette Extraordinary No. 578 dated 4th March, 2016, namely:—

AMENDMENT

In the said notification, in the last sentence, for the figures, symbol and word "1st May, 2017", the figures, symbol and word "1st July, 2017" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government have decided to implement the e-ticketing in cinema theaters, with effect from 2nd May, 2016, as per S. R. O. No. 244/2016 dated 4th March, 2016. Since the installation and implementation of electronic device with an application software approved by the Government, having the facility for access and verification of data or information in respect of the tax due to the local authority could not be completed within 2nd May, 2016, Government have extended the date of implementation of e-ticketing in cinema theaters to 1st May, 2017 due to certain technical reasons as per S. R. O. No. 149/2017 dated 24th March, 2017. Now, due to the reasons stated above, Government have decided to implement the e-ticketing in cinema theaters with effect from 1st July, 2017 and decided to amend the notification issued under G. O. (P) No. 14/2016/LSGD dated 4th March, 2016 and published as S. R. O. No. 244/2016 in the Kerala Gazette Extraordinary No. 578 dated 4th March, 2016 suitably.

The notification is intended to achieve the above object.
